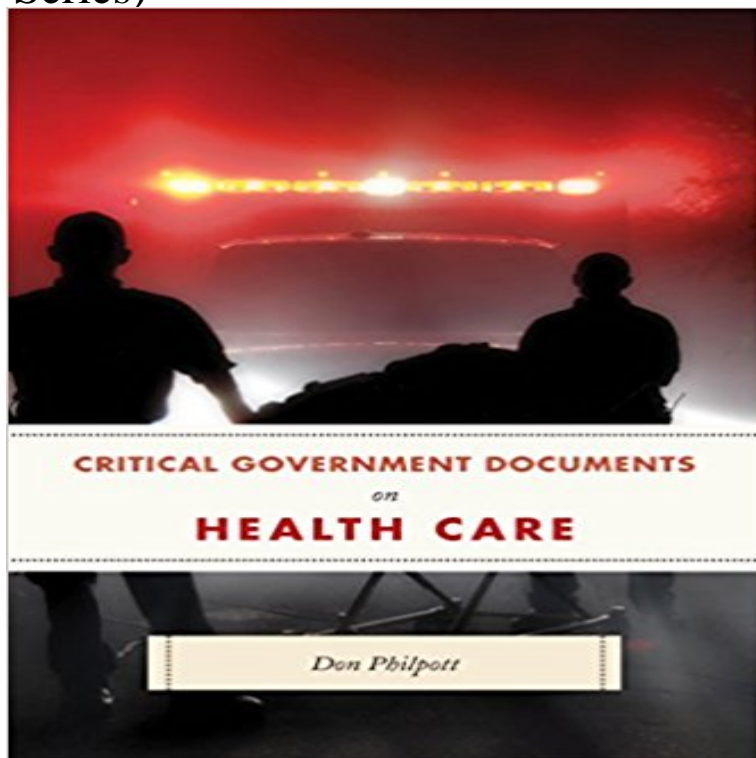


## Critical Government Documents on Health Care (Critical Documents Series)
