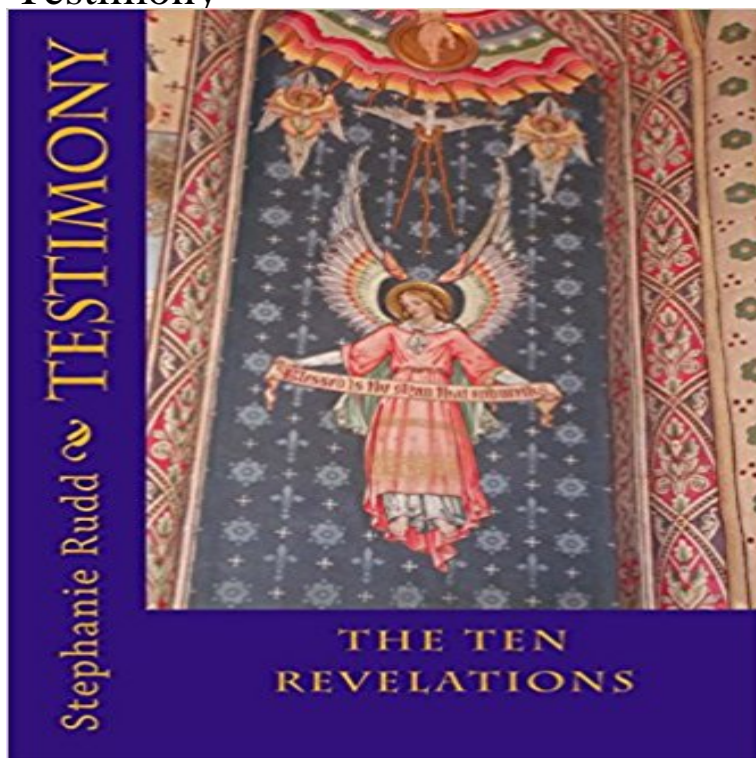


## Testimony
