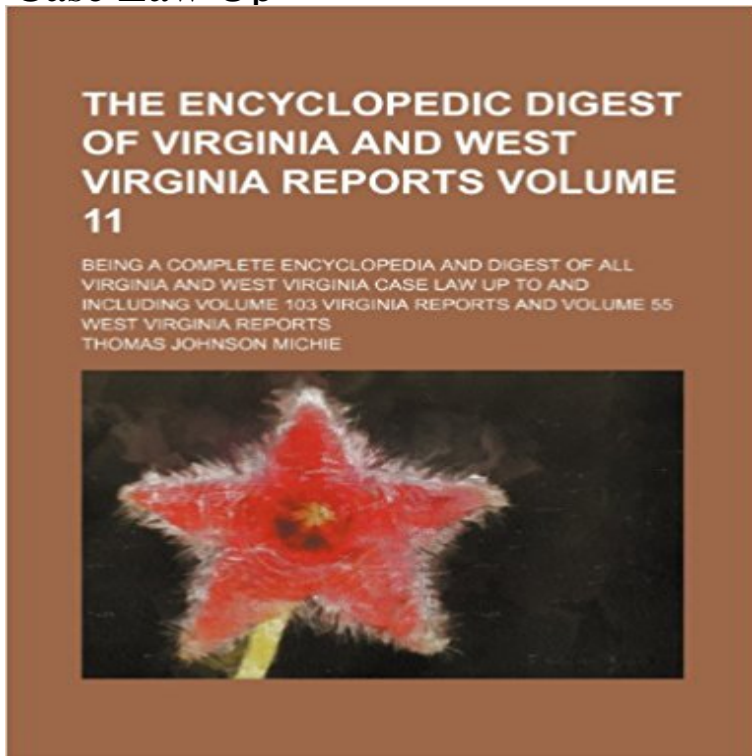

Merely giving additional powers and duties to an office already created and held by an incumbent, does not operate as an appointment of such officer to a different office, so as to offend against 8 of art. 7 of the constitution, denying the legislature the elective or appointive power. *Bridges v. Shallcross*, 6 W. Va. 562. C. MODE OF FILLING VACANCIES PRESCRIBED BY LEGISLATURE. See post, Vacation of Office, VII, C. The constitution of Virginia (art. 5, § 22; Const., 1902, art. 4, § 56), authorizes the legislature to prescribe the manner of filling all vacancies in office, and to declare when an office is vacant, in cases not specially therein provided for, and makes no exception as to the office of judge. *Burks v. Hinton*, 77 Va. 1; *In re Broadus*, 32 Gratt. 779; *Jameson v. Hudson*, 82 Va. 279; *Ex parte Meredith*, 33 Gratt. 119, 38 Am. Rep. 771, overruled. See *Johnson v. Mann*, 77 Va. 265; *Shell v.
