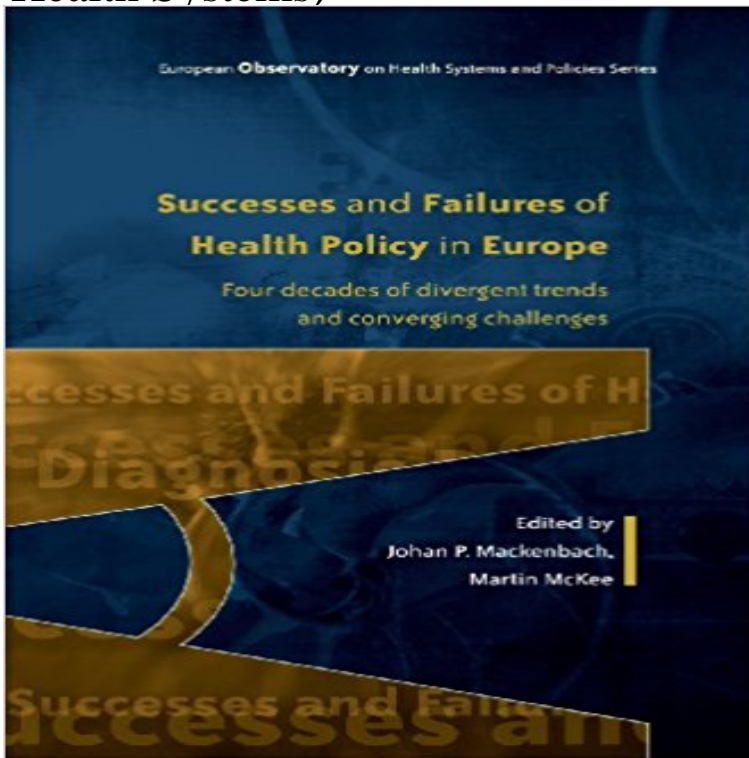


Successes and Failures of Health Policy in Europe: Four decades of divergent trends and converging challenges (European Observatory on Health Systems)
