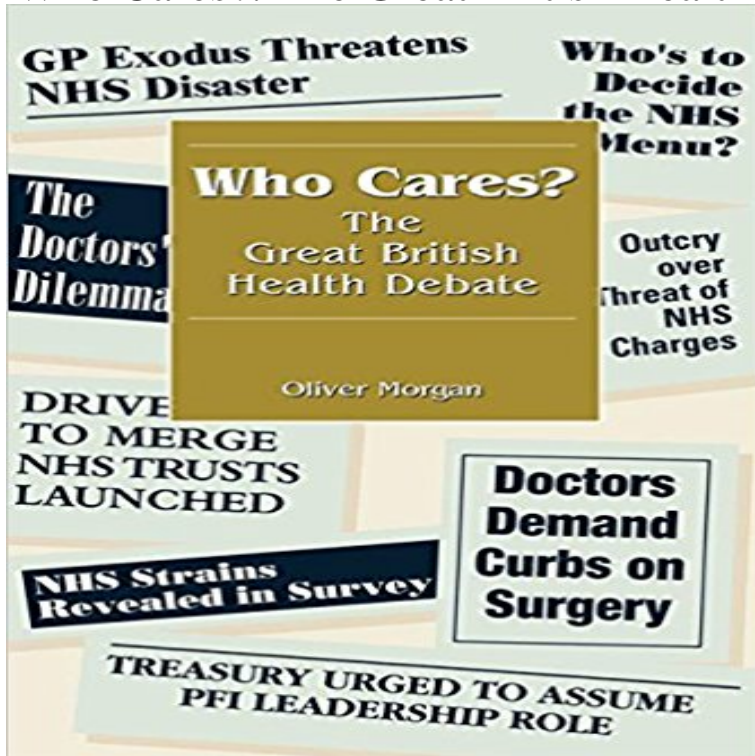


## Who Cares?: The Great British Health Debate
